- ii. That Administrative Departments and their Executing Agencies must provide the mandatory / essential information in the PC-Is duly supported by the quantitative data, maps, charts etc. in order to incorporate requisite information in the revised formats of Working Papers.
- iii. That all the Technical Sections of Planning & Development Department while forwarding copies of Working Papers for TCM and PDWP to Development Section in P&DD, must share copy of working papers with respective Administrative Department(s) for getting necessary input / response before the scheduled meeting.
- iv. The Administrative Departments while convening DDWP meeting, must ensure that the requisite information has been provided in the prescribed revised format of Working Paper for DDWP and share a copy to relevant Section in P&D Department at least (03) days before a meeting.
- v. That revised / improved formats of working papers for DDWP/TCM/PDWP can also be obtained from concerned Technical Section(s) of P&D Department or may be downloaded from the website https://pnd.sindh.gov.pk/project-documents.
